Sphere of Influence Amendment

GC §56425. (a) In order to carry out its purposes and responsibilities for planning and shaping the logical and orderly development and coordination of local governmental agencies subject to the jurisdiction of the commission to advantageously provide for the present and future needs of the county and its communities, the commission shall develop and determine the sphere of influence of each city and each special district, as defined by Section 56036, within the county and enact policies designed to promote the logical and orderly development of areas within the sphere. Kern Delta Water District: Annexation No. 3

A proposed annexation of approximately 150.80 acres consisting of 5 parcels of fallowed agricultural land into Kern Delta Water District. Three parcels are owned by the Kern Delta Water District and two owned jointly with Arvin Edison Water Storage District for the purpose of a joint water recharge project.

This proposal, has 100% landowner consent. The applicant has requested waiver of notice, hearing and protest hearing pursuant to Government Code §56663. (Resolution)
